Final disposition of the Chief Hansen Incident

This is the final update on the incident that took place May 3rd 2008, concerning our Police Chief Dave Hansen. First let me give you an update on the most important thing, that Chief Hansen is doing very well and his lower calf/ankle are making great progress. He is still on crutches but is working sometimes a full day at a time. He has some difficulty doing everything he would like but takes it in stride. He has been very grateful for the many kind thoughts and prayers in his behalf. The community has been very supportive and emails and letters in his behalf have been gratifying.

The Media is what it is

From the first to the last, the Standard Examiner, in my opinion has shown no compassion and only a desire to sensationalize and use only one side of the reports to achieve higher circulation. They may have actually "shot themselves in the foot" on this one, because several have told me they are canceling their subscriptions and one person encouraged me to put an article here to encourage everyone in Riverdale to cancel at the same time to send a message to them about their poor reporting practices. I won't do that and in fact I still take the paper myself; I really don't have another good source for the local obituaries.

To respond or not to respond

My decision not to respond to the various tactless pieces including so called cartoons has not been an easy one. I would love to clear up the misconceptions caused by the paper's coverage, but as we saw in the case of 2nd District court Judge Alphin's criticism of the media coverage "Mother Spared Prison" July 15, and the editorial "A judge's misdirected pique" July 17, the newspaper always has the last word. The judge was blasted by them for daring to criticize how they reported or what they said. To respond in their forum would be futile at best. Their puny free press and government watchdog rhetoric must be an embarrassment to any of them with integrity since they resort to selling newspapers at the expense of a fine Officer and excellent Police Chief.

Investigation and Findings

To make this a complete and thorough investigation from both internal and external viewpoints, there were two separate reviews of the incident. The internal Riverdale City investigation and the independent County Attorney's investigation are both complete. The County Attorney's investigation agrees in every way with our own investigation.

The safety recommendations that were made are being reviewed and implementation is in progress, so that all may benefit in the future. I have given a letter of reprimand to Chief Hansen and he agrees with the findings, and we are all moving on, as we should!

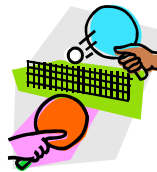


TABLE TENNIS TOURNAMENT

STORYTELLING TIME FOR SENIORS

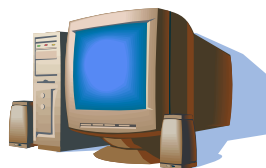
