



MAYOR'S CORNER

Not surprisingly, the City Council and I have been responding to residents inquiries regarding the tentative budget tax and fee increases as recently reported by the newspaper. We appreciate your concern and questions. For the most part they are fair and right on target. Aside from the required Public Meetings and Public Hearings concerning the budget, we will be holding a special Town Meeting at the Senior Center on June 13th at 7:00 p.m. where we can talk further with everyone and respond in a less formal setting to any concerns you might have.

The article in the newspaper was accurate as far as it went. After the meeting in which we adopted this tentative budget, we gave the reporter all of the information and rationale. We respectfully refrain from speculating on why the newspaper includes selective and incomplete information in their coverage of Riverdale City. We are in business primarily to serve the best interest and needs of our residents. They are in business to sell newspapers.

First and foremost, the budget proposal for the tax increase would only affect the small Riverdale portion of the overall county assessed property tax. The actual 2006 tax rate for Riverdale was 0.001131 or 9.0% of the total county property tax. The tax rate proposed in the tentative budget was 0.001680. This worst case scenario rate was adopted subject to and contemplating its possible amendment during the process of adopting the final budget for fiscal year 2007-08.

The City Council did meet as planned on May 19th in their annual budget work session and following considerable discussion did propose amending this tax rate increase to 0.001470. The city tax at this rate would actually cost Riverdale property owners about \$1.55 per month per \$100,000 of county assessed market value vs. \$2.52 per month which was reported as a headline story in the newspaper.

INFORMATION ON PROPOSED TAXES

Recent headlines about a property tax increase in Riverdale have caused many Riverdale residents a fair amount of concern over the past few weeks. Many of you have contacted us, members of your City Council, to ask questions. We have appreciated your interest and the opportunity to discuss this issue with you. Many more of you may have unanswered questions, which we would like to try to address here.

There are a handful of things which we would like to clarify before we discuss what has led to this proposed change in the tax rate:

1. The property tax increase mentioned in the newspaper would apply only to the Riverdale City portion of your property tax bill, not the entire bill. For example, if your property tax bill was \$1000 last year, approximately \$90 of that was for Riverdale City. Any property tax increase that is discussed would be a percentage of that \$90.
2. The 50% property tax increase mentioned in the paper was overstated and preliminary. Since then, the mayor, council and administration have met to review the details of the budget. We cut even more from expenses in the budget, and as we did so, we were able to pare back the proposed increase to 30%.
3. This proposed increase equates to approximately \$18 annually per \$100,000 of home value.
4. The property tax rate in Riverdale has *decreased* steadily since 1998. In 1998, the property tax levy was .001474. The newly proposed increase brings the rate to .001470, or slightly less than the rate of 9 years ago.

As I've mentioned in many newsletter articles, the state legislature basically took more of our sales tax revenues than budget cuts would allow. We have been implementing an action plan over the last two years, and in the past year we have cut almost 1/2 million out of our budget, but without cutting services, we cannot do that again. Last year as I mentioned in my article, over 3 to 5 years this loss of sales tax revenue would be almost a million dollars or about 20% of our budget.

Our Riverdale tax history is that we as a city have not raised the city portion of the property tax for over 20 years. With the proposed tax increase, Riverdale's rate would remain 7th out of 11 cities in Weber county (see chart below).

Our commercial business district will carry a heavier portion of this tax increase burden since they do not benefit from the primary residence tax which is assessed on only 55% of market value. Businesses will pay the higher rate on 100% of assessed market value.

While the above points may put the proposed increase in perspective, it does not necessarily make it much easier to swallow. A tax increase is a tax increase and it makes all of us, including members of the City Council, frustrated at the prospect. We hope a little more background will help to make clear why we are in this situation.

We are all aware that sales tax is a significant component of our city budget. To put it in perspective: In the 2005-06 city budget, our assessed property taxes accounted for approximately \$368,000 while sales tax accounted for \$4,939,651 – approximately 13 times the amount of property tax. Obviously, any change in sales tax can have a significant impact on our city budget.

A few years ago, some state senators from Davis and Utah Counties began pushing to take sales tax revenues from cities such as Riverdale and “redistribute” them to other cities with larger resident populations. Because of the potential impact, Riverdale city officials and administration became actively involved in the discussion. Thanks to the support of our Representative, Brad Dee, and support of leadership in the House, we were able to mitigate the impact of the legislation by avoiding a pure “population-based” distribution and spreading the implementation of this redistribution over a 7 to 10 year period. (The full details of the current status of that battle are the topic of another article.) But the negative effect is that our sales tax revenue will be reduced by one-third, or approximately \$1.5 million over the next 7-10 years with \$400,000 of that impact hitting us in the first year. While this is a marked improvement over what was originally proposed, it is still a significant impact to how we fund services in our city.

Knowing that some reduction in sales tax revenue was inevitable as a result of legislation, city officials and administration have spent the last few years reviewing options to provide services while managing the budget as these reductions would occur. We are working on or have already implemented the following options:


- Delay or eliminate some major city projects, such as street improvements, etc.
- Reduce, where possible, ongoing city expenses.
- Work with legislative leadership to further amend how sales tax revenues are distributed or other sales tax benefits for cities with disproportionate populations to retail bases.
- Increase sales taxes received through additional retail sales in our city.
- Adjust property taxes for businesses as well as residents (businesses will pay property tax on 100% of assessed value while homeowners pay only on 55% of value).
- Changing our fee-for-use for some services in our city, particularly for non-resident fees.

When it is all said and done, our goal is to provide an optimum level of services for residents while keeping the overall cost of living in Riverdale low. Based on comparative information to other cities for property taxes, water, sewer, garbage fees and franchise taxes, we are succeeding at this. As an example, if you live in a home worth \$150,000, use less than 15,000 gallons of water per month, have one garbage can and have average energy and telecommunications bills of \$40 per month, your annual current taxes and fees paid to the city are \$431. The next lowest of 11 cities in South Weber County or North Davis County is \$622 annually. The highest city in the same area is \$1187 annually. We believe this is testament to our ability to maintain a relatively low cost to our residents while efficiently providing services and, as your City Council, we are committed to continue to keep costs low for residents of our city.

LAWN & GARDEN DIAGNOSTIC CLINICS

We will also invite the Fire Department to showcase a fire truck for the kids to climb on and we will also show off some of our police toys as well and even give a ride in a police car for those interested.

We have found great success in this approach and think it helps us get to know you and you to get to know us. Our officers love working here and want you to be as safe as possible.
